6	<p>Safeguarding</p> <p>Does the provider have policies to protect students from extremist materials? (incl. in safeguarding policy)E.g.</p> <ul style="list-style-type: none"> i) Online safety: Reference to Prevent duty / filters to restrict extremist websites / info to and contract with staff and students about accessing extremist material on personal IT / response for failing to follow policy ii) Materials displayed: Student handouts/ notices posted on campus, especially those not in English to be checked? iii) Outside speakers / sub-lets: Are outside users of the campus / facilities appropriate? What is procedure for checking?

9	<p>Policy(ies)</p> <p>Are above points covered in Prevent policy inclusion in existing safeguarding policy/separate policies/combination of these?</p> <p>Do policies include record keeping procedures (e.g. training / concerns / referrals to outside agencies)?</p>
